



EXPRESSION OF INTEREST FOR PROVISION OF FOUR WELLHEADS & RELATED SERVICES

Eni Rovuma Basin B.V., Mozambique Branch, on behalf of Eni Mozambico S.p.A, invites interested companies to submit their *Expression of Interest* for the provision of **FOUR WELLHEADS & RELATED SERVICES** to support operations in Area A5-A in Mozambique.

SCOPE OF WORK

The scope of work consists of provision of FOUR WELLHEADS & RELATED SERVICES, as detailed below in order to perform the drilling activities for the deepwater exploration campaign of 1 well plus 2 optional wells:

- Provide 4 Complete set, inclusive of accessories, of subsea wellhead 36" – 18 ¾" 15000psi in compliant with ISO specification 13628-4 / API SPEC 17D.
 - o Rated working pressure 15.000psi
 - o Temperature rating class 5 (2deg to 121deg)
 - o Material class DD-NL (sour services) as per ISO 10423 / API SPECS 6A
 - o Product specification levels: PSL 3
- Required Services:
 - o 2 set of Rental equipment (tools for running tools, pulling, testing, washing and any relevant tools) including adequate quantity of spare parts,
 - o Well site assistance personnel,
 - o Packing, offshore skids, shipping,
 - o documentations
- Dedicated logistic base in Pemba surroundings, embarkation point for the equipment will be Pemba Port.

The expected spud-in date of the 1st well is in Q1 2021, and Contractor shall be ready to operate by November 2020.

The delivery of wellheads will be required tentatively at the end of October 2020.

DOCUMENTATION REQUIRED

I. Technical documents:

- a) Any relevant references for the previously executed projects of similar technical characteristics and magnitude;

- b) Quality Management System certifications and/or certificates proving compliance with international Quality Standards (ISO 9001:2008);
- c) Health & Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
- d) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
- e) Any other information that will establish ability of fulfilling this scope of work.

II. Administrative documents:

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Company;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange).
