



**EXPRESSION OF INTEREST
PROVISION OF CARGO CARRYING UNITS, SLINGS, LIFTING ACCESSORIES AND

Eni Rovuma Basin B.V., Mozambique Branch – Offshore Delegated Operator, acting for and on behalf of **Mozambique Rovuma Venture, Area 4 Operator**, invites interested companies to submit *Expression of Interest* for the provision of Cargo Carrying Units (CCU's), Slings, Lifting Accessories and Recertification as specified below.

SCOPE OF WORK

Applicant shall be capable of providing CCU's (i.e. tanks, containers, baskets, mud/waste skips, standard ISO tank containers, skid containers, racks and frames), slings (i.e. webbing, chains and wire rope slings) and Lifting Accessories (i.e. fittings, clips, shackles etc.) for rental and/or purchase primarily in Pemba, and other locations along the Mozambique coastline ranging from Palma to Nacala.

Applicant shall also be capable of providing third party certification services for the above listed items. All goods and services shall be provided in compliance with DNV 2.7-1 / EN 12079 and applicable national and international standards.

Services will be required indicatively starting from Q2 2019 for a period of up to 24 months.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* by providing the following mandatory information and documentation:

- 1- Alvará which attests your Company for the provision of services herein requested;
- 2- Health & Safety Management System certification and/or documents proving the Company compliance with international standards (ISO 14001 & 9001, OHSAS 18001);
- 3- Your Company's HSE performance of last three years;
- 4- Proven experience in the provision of CCU's, Slings and Lifting Accessories in Mozambique, including any relevant references from previous clients for the provision of similar services in Oil & Gas industry;

- 5- Brochure/booklet of CCU's, Slings and Lifting Accessories;
- 6- In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group;
- 7- Last three years of Financial Statements and Annual Reports including Balance Sheet, Profit and Loss and Cash Flow Statement proving minimum financial capability to carry out the scope. These documents must be provided for the Company Group (if applicable), and also for the Company's entity that will potentially enter into the subject contract;
- 8- Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique;
- 9- Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification and other relevant information from Eni Rovuma Basin B.V.;
- 10- Company and Group structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- 11- Any other information that will establish that your Company is capable of fulfilling the scope of work.
