



EXPRESSION OF INTEREST FOR SECURITY SERVICES IN MOZAMBIQUE

Eni Rovuma Basin B.V., Mozambique Branch invites interested companies to submit *Expression of Interest* for the provision of SECURITY SERVICES in the Republic of Mozambique.

SCOPE OF WORK

Contractor's scope of work will consist of integrated Security Services to be executed in Mozambique (mainly in Maputo, Nampula, and Cabo Delgado provinces, but not limited to such provinces) in compliance with the relevant Mozambique legislation, maintain an internationally acceptable security standard for the protection of the Company and its Sites, personnel, materials, business and information.

Security Services shall include, but not be limited to:

- Armed Personal Security Teams;
- Armed / Unarmed Local Guard Forces;
- Offshore / Onshore;
- Security of Personnel, Assets, Transport means etc.

Contractor shall implement a physically robust, intelligence lead security function, facilitating Company's business activities within Mozambique.

Services will be required indicatively starting from the beginning of 2020 for a period of 3 (three) years, with a further possible extension of 1 (one) year.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* by providing the following mandatory information and documentation:

1. Documented evidence of being registered with Government of Mozambique, and being specifically licensed by the Ministry of Interior (MoI);
2. Insurance documents to provide armed security services in Mozambique;

3. Memorandum of Understanding with the Host Government Security Forces (HGSF) for the static and mobile armed security service in ONSHORE and OFFSHORE locations;
4. Health & Safety Management System certification and/or documents proving the company compliance with international standards (ISO 9001 and 45001);
5. In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group;
6. Scanned Certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification and other relevant information from Eni Rovuma Basin B.V.;
7. Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
8. Last three years of Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will potentially enter into the subject contract;
9. Any other information that will establish that the company is capable of fulfilling the scope of work.
